



PUBLIC HEARING MINUTES

June 20, 2013

- I. Bruce A. Wahl, Mayor, called the public hearing to order at 7:30 p.m. In attendance were: Dr. Valerie L. Beaudin, Robert E. Carpenter, Stewart B. Cumbo, Jeffrey J. Krahlung, Patrick J. Mahoney, and Eric M. Reinhardt, Council Members, Elissa Levan, Town Attorney, Sharon L. Humm, Town Clerk, Leslie Porter, Town Treasurer, Cheri Beard, Assistant Treasurer, Jay Berry, Superintendent of Public Works, William Watson, Code Enforcement Officer, Paul Woodburn, Town Engineer, Marilyn Van Wagner, Water Park General Manager, Jon Castro, WWTP Superintendent, Chris Jakubiak, Zoning Administrator and Frist Sergeant Jones. Absent was Dr. James Parent, Town Administrator.

Ordinance O-13-7, an Ordinance of the Town Council of Chesapeake Beach, Maryland adopting the annual budget for the Treatment Plant Fund of the Town of Chesapeake Beach for the fiscal year July 1, 2013 to June 30, 2014.

Mrs. Porter stated the Treatment Plant is owned by 3 entities, the Town being the lead owner and operator of the Plant and costs are allocated among the various owners and its partner, Anne Arundel County. Mrs. Porter said the major project in the upcoming year is the start of the ENR project. Mrs. Porter reported the estimated cost to operate the Plant is \$7,170,000 of which \$574,00 is fixed, \$576,000 is variable and capital, is \$6,020,000 which is the portion of the ENR project. This fund has to self-balance itself.

There being no further comments the hearing was closed at 7:43 p.m. on a motion by Mr. Mahoney. Seconded by Mr. Krahlung, all in favor.

Ordinance O-13-8, an Ordinance of the Town Council of Chesapeake Beach, Maryland adopting the annual budget for the Utility Fund of The Town of Chesapeake Beach for the fiscal year July 1, 2013 to June 30, 2014 and setting rates, charges and fees related to water and sewer service by the Town.

Mrs. Porter gave a breakdown of the Utility Fund Revenues highlighting sewer and water operations, projected capital connection fees and Grants and Loans, giving total revenues. As with Expenses, highlighting water and sewer operations, water and sewer debt service and capital projects.

Mrs. Porter went over the proposed Fee and Rate Schedule highlighting the sewer and water use rate minimum charge, based on meter size, and usage charge per 1000 gallons.

Mr. Krahling stated that he would be making a motion to amend Ordinance O-13-8 to replace the introduced Schedule A with a Flat Rate Schedule A and submitted a copy to each Council member.

Ordinance O-13-9, an Ordinance of the Town Council of Chesapeake Beach, Maryland, amending Chapter 104, "Animals," of the Code of Chesapeake Beach to add a new Section 104-2 "Prohibited Animals", prohibiting farm animals from being kept within the Town of Chesapeake Beach, providing for the enforcement of Section 104-2 and renumbering existing Sections 104-2 and 104-3 of the Town Code.

The Town Attorney explained that the Town presently is under the Calvert County Animal Control Ordinance. Ordinance O-13-9 will enable the town to add a new section in which the Town can prohibit the keeping of farm animals that are presently allowed under the Calvert County Code.

- A. Deputy's Report** – First Sergeant Jones submitted the attached written report and addressed the Council's concerns.
- B. Public Works Report** – Mr. Berry submitted the attached written report. Mr. Berry briefed the Council on the water issue that occurred at Richfield Station water tower.
- C. Code Enforcement Officer's Report-** Mr. Watson submitted the attached written report and addressed the Council's questions.
- D. Town Engineer's Report** – Mr. Woodburn submitted the attached written report. Mr. Woodburn gave an update on the MD Route 261 sidewalk project and possible crosswalk from Chesapeake Village to Bayfront Park.
- E. Water Park Report** – Mrs. VanWagner submitted the attached written report and was present to address the Council.
- F. Wastewater Treatment Plant Report** – Mr. Castro submitted the attached written report. Mr. Castro expressed his appreciation and well wishes to newly retired employee Bob Haynes. The Mayor presented a plaque from the Mayor and Town

Council to Mr. Haynes for his service and dedication to the Town during his years at the Wastewater Treatment Plant.

- G. North Beach Volunteer Fire Department Report** – Mr. Gordy submitted the attached written report but was not present to address the Council.
- H. Treasurer’s Report** – No report.
- I. Chesapeake Beach Special Events Report** – Mrs. O’Dell submitted the attached written report. Mrs. O’Dell thanked everyone for their help and support in making the Stars and Stripes Festival a success and recognized the Beach Elementary children for their wonderful art work done in support of the festival. Mrs. O’Dell gave a brief update on upcoming events.
- J. Mayor’s Report** –

1. The Mayor thanked everyone for coming out and showing an interest in their local government. He reported the State Highway Administration held a meeting on the new proposed Fishing Creek Replacement Bridge with hopes of being out to bid by fall with a targeted completion date of 2017.

2. The Mayor thanked the Chesapeake Beach Resort and Spa for a great job in hosting the 3rd SMPTE Society conference which he attended.

3. The Mayor stated the MML Convention is next week and five of the six Council members, himself and several of the town staff will be attending.

4. The Mayor gave his regrets for not being able to attend the Stars and Stripes Festival as his brother-in-law passed away and wanted to publicly acknowledge the support shown by the Nam Knights and Councilman Krahling for his family.

VI. Resolutions & Ordinances

- A. Vote on Ordinance O-13-7, an Ordinance of the Town Council of Chesapeake Beach, Maryland adopting the annual budget for the Treatment Plant Fund of the Town of Chesapeake Beach for the fiscal year July 1, 2013 to June 30, 2014.**

MOTION: Mr. Mahoney moved to approve Ordinance O-13-7, adopting the annual budget for the Treatment Plant Fund for the fiscal year July 1, 2013 to June 30, 2014. Seconded by Dr. Beaudin, all in favor.

- B. Vote on Ordinance O-13-8, an Ordinance of the Town Council of Chesapeake Beach, Maryland adopting the annual budget for the Utility Fund of The Town of Chesapeake Beach for the fiscal year July 1, 2013 to June 30, 2014 and setting rates, charges and fees related to water and sewer service by the Town.**

MOTION: Mr. Mahoney moved to approve Ordinance O-13-8, adopting the annual budget for the Utility Fund for the fiscal year July 1, 2013 to June

30, 2014 and setting rates, charges and fees related to water and sewer service by the Town. Seconded by Dr. Beaudin.

MOTION: Mr. Krahling moved to amend Ordinance O-13-8 as was introduced and replace the introduced Schedule A with the uniform flat rate Schedule A which was provided earlier to the Council. Seconded by Mr. Reinhardt.

During Council discussion it was determined that figures presented on the Flat Rate Schedule A were not factual and did not meet the revenue targets.

MOTION: Mr. Krahling moved to amend his amendment to replace the introduced Schedule A with the Flat Rate Schedule A with the adjusted figures per Mrs. Porter of \$11.28 per 1000 gallons for sewer and \$4.28 per 1000 gallons of water in order to meet the revenue targets. Seconded by Mr. Mahoney.

MOTION: Mr. Carpenter moved to amend the amendment to add a \$25 per quarter administrative fee for zero usage users. Seconded by Mr. Cumbo. Ayes, Mr. Carpenter and Mr. Cumbo. Opposed, Dr. Beaudin, Mr. Krahling, Mr. Mahoney and Mr. Reinhardt. **Motion Fails.**

MOTION: Mr. Carpenter moved to amend the amendment to add a reconnection fee to non-usage users for a period of one year. **The motion died for a lack of a second.**

The Council voted on the amendment as presented by Councilman Krahling. Ayes, Dr. Beaudin, Mr. Krahling, Mr. Mahoney and Mr. Reinhardt. Opposed, Mr. Carpenter and Mr. Cumbo. **Motion Passes.**

The Council voted on Ordinance O-13-8 as amended. Ayes, Dr. Beaudin, Mr. Krahling, Mr. Mahoney and Mr. Reinhardt. Opposed, Mr. Carpenter. Abstained, Mr. Cumbo. Ordinance O-13-8 **Passes** as amended.

C. Vote on Ordinance O-13-9, an Ordinance of the Town Council of Chesapeake Beach, Maryland, amending Chapter 104, "Animals," of the Code of Chesapeake Beach to add a new Section 104-2 "Prohibited Animals", prohibiting farm animals from being kept within the Town of Chesapeake Beach, providing for the enforcement of Section 104-2 and renumbering existing Sections 104-2 and 104-3 of the Town Code.

MOTION: Mr. Mahoney moved to approve Ordinance O-13-9 amending Chapter 104 "Animals". Seconded by Dr. Beaudin.

MOTION: Dr. Beaudin moved to amend Ordinance O-13-9, by creating in "104-2 Prohibited Animals", 2 sections, 1) "A" as it currently reads and a new section "B" to read "it shall be unlawful for any person to keep, raise or maintain any live farm animal within the corporate limits of the town greater than the number 5 (example 5 rabbits) or to operate a commercial breeding operation with respect to such animals".

After further discussion Mr. Cumbo suggested to table Ordinance O-13-9 until next month.

MOTION: Dr. Beaudin moved to table Ordinance O-13-9. Seconded by Mr. Mahoney, all in favor.

- D. Introduce Ordinance O-13-10, an Ordinance of the Town Council of Chesapeake Beach, Maryland, repealing all prior ordinances or part or parts thereof adopting any comprehensive zoning map for the Town and any ordinances approving any piecemeal rezoning, and adopting a new comprehensive zoning map, designating the boundaries of the respective zones identified and defined in the Chesapeake Beach Zoning Ordinance, for the purpose of determining the applicability of the various provisions of said zoning ordinance, the Chesapeake Beach Subdivision ordinance, and any other pertinent ordinances, resolutions or regulations of the Town to particular lots and parcels situated therein.** A public hearing will be held at 7:45 p.m. prior to the next regularly scheduled meeting.

VII. Report of Officers, Boards and Committees:

- A. Planning & Zoning Commission** – There was a meeting held June 12, 2013. Mr. Jakubiak was present to address the Council.
- B. Board of Appeals** – There was no hearing held in June.
- C. Water Park Advisory Board** – No report.
- D. Skateboard Park Committee** – Mr. Carpenter asked Council to consider approval of the skateboard park design. Mr. Cumbo and Mr. Mahoney suggested Mr. Carpenter present the design to the Council at the July Town Council meeting. Mr. Carpenter agreed.
- E. Election Advisory Committee** – Mr. Carpenter requested that a Council work session be scheduled with the Board of Elections to discuss the drafted ordinance on campaign finance.
- F. Chesapeake Beach Oyster Cultivation Society Committee** – Mr. Bacon was present to give the water monitoring report.
- G. Bayfront Park Committee** – Mr. Mahoney gave thanks to Dr. Parent on his motivation and zeal in his efforts in resolving issues that have come up at the park.

- H. Beach Elementary Redistricting** – The Mayor reported that the President of the School Board informed him that they voted not to pursue redistricting this year, that the time frame was too short and are considering installing portable classrooms. Mr. Carpenter added that Dr. Karol assured him that they are going to stay on top of this issue.

Mr. Morris stated he is preparing a letter to the Town concerning a parcel owned by the Town requesting the Town deed the parcel to the R/F Station HOA.

MOTION: Mr. Mahoney moved to reconsider the awarding of the 5 “Wi-Fi” self-powered surveillance camera systems. Seconded by Mr. Cumbo. Ayes, Dr. Beaudin, Mr. Carpenter, Mr. Cumbo, Mr. Krahlung and Mr. Mahoney. Opposed, Mr. Reinhardt. **Motion Passes**

MOTION: Mr. Mahoney moved to approve awarding a contract to Celtic Sentry Security in an amount not to exceed \$41,950 to provide all equipment and labor necessary to install 5 “Wi-Fi” self-powered surveillance camera systems along the Town’s Boardwalk trail. Seconded by Dr. Beaudin. Ayes, Dr. Beaudin, Mr. Carpenter, Mr. Cumbo, Mr. Krahlung and Mr. Mahoney. Opposed, Mr. Reinhardt. **Motion Passes.**

4. Mr. Krahling thanked everyone for coming out and the support shown on the water rate structure. Also, expressed thanks to Mrs. Porter and the Mayor for their help in producing correct figures for the flat rate structure.
5. Mr. Cumbo also thanked Mr. Berry on the Richfield Station water issue.
6. Dr. Beaudin invited everyone to come out and support the Dragon Boat Races on Saturday in an effort to raise money for End Hunger. Dr. Beaudin stated she was disappointed though that the redistricting of Beach Elementary didn't go forward and reminded everyone that next month's meeting will involve a public hearing and vote on the Comprehensive Zoning Map.

Public Works Report

Water Park- We repaired all of the known leaks at this time. The Park is up and running and I will continue fixing minor repairs before they open each day.

Graffiti -There was a bench on the Bay Front Park boardwalk that was spray painted last week. We have since removed the paint.

Water leak- We had a water leak on Richfield lane in Richfield Station. This leak has been repaired.

Wet wells- This month's PM is scheduled for Bay View Hills. At the time of this report we have not completed this PM check. We had to pull pump 2 at Chesapeake Village do to it running more minutes than usually. I will be performing a load and amp test on this pump.

Water meter/MXU- The Public works crew is still ongoing in their efforts to change out mxu's. We continue to work in the Bay View hills development along with other areas in Town. In the Town house sections this involves an appointment with the home owners as the meters are inside. This is still ongoing.

Ball fields - We continue to maintain the fields. Nothing remarkable to report at this time.

Rail Way Trail- We are still adding top soil in various places along the trail. We have also had several small trees and large branches to deal with in this very stormy month of June.



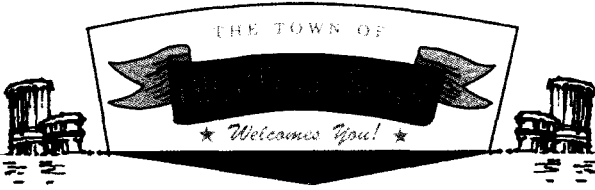

NEW BUSINESS

Trail – A final title report has been delivered which outlines that the Town does have title to the trail bed through Richfield Station. There are a few old development bank liens that need to be cleaned up and the attorney is moving forward getting this done.

WWTP – The notice to proceed has been given to the contractor and the first construction meeting was held on June 10, 2013.

Richfield Station Water Tower – The tank and lines were flushed a second time to put the town back online.

Fishing Creek Dredge – We are working with the Corps of Engineers to close the site out and close all open permits.

Fishing Creek Bridge – The project is moving fast as weekly coordination meetings are being held. Attached is a rendering of the project which is still on target to start this fall.

Veterans Park – Preliminary design and information gathering has begun to move this project forward.

OLD BUSINESS

Trail – Concept site plans for a Trail extension from the Trestle and thru the Richfield Station Rail bed have been developed and provided to the Critical Area Commission and the State Highway Administration (SHA). We are currently researching critical area woodland mitigation possibilities and property title issues (we spoke to the Title Abstractor Terry Erder on 1/9/13 and more research has been completed – an extensive report has been compiled from Terry which she believes gives title to the town). We are currently seeking guidance from title attorneys and the town attorney to gain title insurance. Preliminary Environmental studies are complete to move forward with the Trail extension plans and the Critical Area Commission has requested a meeting to help move us through the process. The meeting was held and they presented several mitigation programs. We also marked in the filed the trail alignment for a field review by the C.A.C. The C.A.C. approved the concept plan.

WWTP – (ENR upgrades) – All permits have been issued and construction bids were received November 30th. Bid award packages have been sent to MDE for approval and funds procurement. All contracts are executed and work will commence soon.

Kellams Field – We are working with American Irrigation to determine the connection needs (pressure & volumes) for the purple pipe. This work can be performed in conjunction with the WWTP upgrades. We hope to install most of the improvements this summer with available grant funding.

Richfield Station Water Tower – Inspection of the facility has been completed. The inspection report recommendations outline the need for the tank to be cleaned and repainted on the inside and outside of the tank. Corrosion Control Corporation is under contract to perform the Phase One interior work. The interior work of Phase One cleaning and painting is complete. We will begin refilling and the sterilization process on or about the 19th and anticipate being back online by May 6th.

Water Park – Short and long term maintenance, repair and upgrade items are being evaluated. Budgeted repair work items are currently underway.

‘E’ Street Pump Station Influent Sewer Pipe and Storm Drain Inlet/Pipe Repair - The Town will be performing test holes over the sewer pipe to determine the extent of the ‘belly’ in the pipe and around the inlet. Recommendation for repairs will follow the test holes investigation by the Public Works staff.

Skate Park – Final design plans are ongoing by the skateboard consultant.

Purple Pipe – We are developing layouts for installation of the pipe to serve the Route 260 landscaping areas and Kellams Field. Operation of the system will commence with the ENR project.

Fishing Creek Dredge – The U.S. Army Corps of Engineers has given the Notice to Proceed and the contractor has completed repairs to the existing spoil site. The contractor has mobilized and dredging is underway. Dredging should be complete in the next few weeks. Currently sand material is being transported to the areas just off of Brownies Beach.

Fishing Creek Bridge (MD Rt. 261) – We are continuing to coordinate with the MSHA design team for the bridge replacement project. We were informed that the project is funded and scheduled to bid in 2013 with a 2015 construction completion anticipated. SHA has taken a second look at the bridge geometrics and is currently working with the Town to work out design and construction specifics. We are also working with the various utility companies (AT&T, Verizon, Comcast and BGE) to have their utilities relocated prior to construction. The Town has also recently met with SHA to detail the relocation of the Town water and sewer lines, and all overhead utility lines. We continue to assist SHA in their design efforts.

MD Route 261 Sidewalk – Design plans are underway to extend a pedestrian walkway from Beach Elementary School to Chesapeake Village and Bayfront Park. The site survey and environmental plans are complete. Preliminary discussions with the Critical Area Commission and the State Highway Administration have commenced to gain their support of the project and the alignment.

Chesapeake Beach Wastewater Treatment Plant Report

Plant Operation:

Staff employee Bob Haynes retirement date is June 21, 2013. Interviews for Bob Haynes replacement were held on June 3rd, 4th, and 10th. We have an applicant under consideration.

The EPA DMR-QA Study 33 tests were performed by plant staff on 4-22-13. The study will test the accuracy of the plants daily lab tests along with the lab contractor the plant uses. We have received the first round of test results on June 3, 2013 and passed.

I attended the Boy Scouts meeting at the American Legion on May 13, 2013 to talk to a group of scouts on the Wastewater Plant Operation and be interviewed for the scouts to acquire a communication badge.

The Pre construction meeting was held on June 4, 2013 at the Town Hall for the ENR Upgrade. The notice to proceed date was issued as June 10, 2013. The construction sequence was discussed to help the plant operation get through the major upgrade projects.

There were no incidents to report in the plant's Solids and Handling Operation or the Lab Sampling Operation with Duffield Hauling and Chesapeake Labs.

Plant operations for this monthly report did use the Shell Fish Tank on four occasions since the last report. The split flow occurrences were due to rain during a storm. The last time it was put into operation was on April 5, 2013.

The plant had two emergency alarms responded to during this period, one for a clarifier shutdown and an Influent Pump shutdown. Plant staff also checked on the plant operation on several occasions after working hours to check operations during split flow mode during rain storms.

The Wastewater Treatment Plant had no spills or violations to report.

Future Projects:

The ENR Project for the Chesapeake Beach Wastewater Treatment Plant has completed the permit process and design stage. The bid for the ENR construction was awarded to Bearing Construction and should start construction June 10, 2013.

The plant records will be put into the Sure Scan System with the help of Town Employee Fran Addicott to ensure a better system of storing plant data.

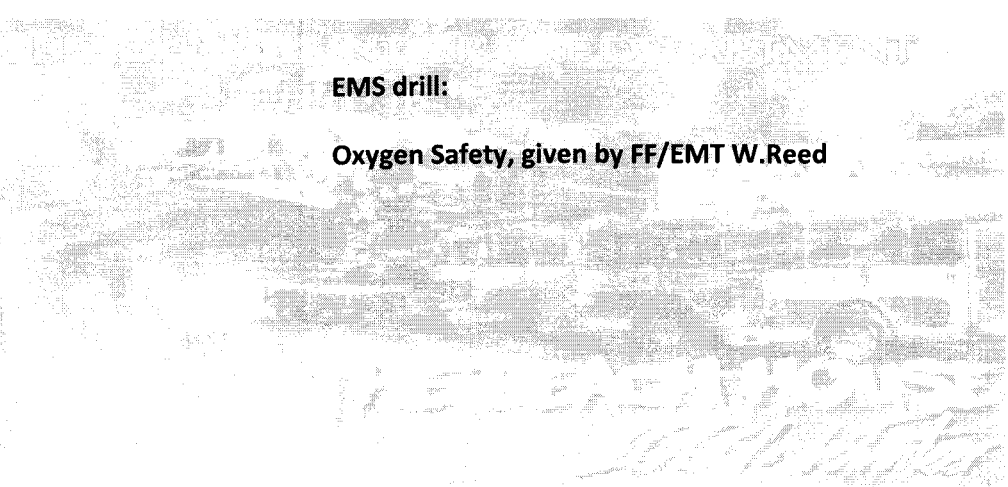

The **Planning Commission** met on June 12, 2013.

1. It reviewed and approved a concept plan for future parking lot improvements and the establishment of a critical area "buffer yard" associated with the Abner's Game Room Addition project.
2. The Planning Commission also reviewed its Annual Report for 2012 but postponed action on approving it until its July meeting.
3. The concept site plan for the proposed 10-unit condominium project at 28th and C Streets (Sunrise on the Chesapeake) will be heard at the July 10th meeting.
4. The Planning Commission will hold a special working meeting on July 11th to preliminarily consider updates to the critical area regulations.

The **Board of Appeals** was set to continue its hearing on the Joyce Sizemore appeal on June 18, 2013 but at the request of the applicant's attorney who experienced a scheduling conflict, the Board has agreed to reschedule the hearing. A new date has not been set.
